Batches :

This module monitors the Assessments of Batches Assigned, rejected, completed and provides the clear numbers in terms of Batches and Candidates as following:-

A) <u>Assigned Batches-for assessment:</u> This tab provides all assigned batch details with assessor for assessment with all individual candidate's and AB's complete information like AB Name, Sector, batch start date, end date, assessment date etc . This feature also provides option for Offline uploading of result.

B) Rejected by AB:-

This tab provides complete details of batches Rejected by AB with assessor name, AB name, batch start date, end date, assessment date etc and with different other useful details in terms of related schemes, centre nameetc.
